Purchasing Oregon IDA Tax Credits With Credit or Debit Cards Online

Thank you for your interest in purchasing Oregon IDA Tax Credits online! Here are a few suggestions to make the process easier to complete.

- Step 1:** Please ***contact your credit card in advance to secure advance approval*** of the transaction. Google has a \$25,000 per transaction limit, so if you are planning to donate more, please advise your credit card to approve multiple transactions.
- Step 2:** Log onto <http://ida.neighborhoodpartnerships.org> Press the link that says ***I'm ready to contribute to the IDA tax credit***, then go to the link that says ***Donate Now ONLINE*** and follow the instructions for donating.
- Step 3:** Please ***check your Google email account regularly for messages*** about the transaction, especially when it is near the end of the year. When you make a contribution to purchase Oregon IDA Tax Credits, you are asked to create a Google account. All messages regarding your contribution are sent to the Google email address.
- Step 4:** Please retain receipts and records. **Your contribution will appear on your credit card statement as "Google—IDA Tax Credit."**

We are not able take credit card contributions over the phone at this time.

Contributions must be received by ***midnight pacific time*** on December 31 2012 to be eligible for 2012 Oregon tax credit.

Instructions for Purchasing Oregon IDA Tax Credits with Stocks or Mutual Funds

*If you are purchasing Oregon IDA Tax Credits with Stocks or Mutual Funds, we must receive them in our account by **December 31 2012**; we advise to initiate the transfer well before as the transfers can take a few days to arrive in our account. Thank you.*

Step 1: Please mail or fax the Tax Credit Donor Form, with your complete contact information and stock detail, to the Neighborhood Partnerships.

Step 2: Transfer the securities from your account to the brokerage account for the Neighborhood Partnerships at Chase.

Step 3: When you initiate the transfer, notify Kathy Turner at 503-226-3001 x101 or kturner@neighborhoodpartnerships.org so that we can monitor the NP account, sell the stocks when they arrive and connect them back to the donor. The sale price will establish the final value and the number of tax credits purchased.

A receipt will be sent to you within 5-7 business days of the transfer.
